		Walking/Biking pathway: Bremerton > Silverdale > Poulsbo
		Rhode Island's East Bay Bike Path is a model for such a pathway. It runs for fourteen miles from Bristol to Providence. Along this pathway, one is at times touring beside the beautiful Narragansett Bay, or transiting between towns (where lemonade stands and bicycle shops have popped up), or riding through pleasant, small-town neighborhoods, or stopping to stroll on a town's main street, or resting in a park and eating lunch. We propose that the Urban Reserve Zoning be changed to Urban Restrictive Zoning, whereas the density could be limited to a level reflecting the past smaller developments that occurred in the area. This could be an area where attractive homes could be built on larger lots, such as one quarter acre, one half acre and one acre lots, with room for home gardens, fruit trees and children to play in their own yards. For those that do not have a need to develop or sell a portion of their land at this time, we would hope that policies would encourage their use of the land in a rural nature, with the encouragement of agriculture and forestry.
